The terms of reference of the State Level Skill Development Council shall be

1. To provide inter sectoral coordination through involvement of experts and representatives and to use the existing infrastructure of public educational institutions for skill development.
2. To increase the number of trained personnel per year to include those who have not been covered as yet for optimum utilization for public and private training capacities.

3. Utilisation of financial resources for bringing about qualitative changes in training using the existing institutions through upgradation of infrastructure in terms of curriculum revision, modernized labs, adequate number of proper trainers etc.
4. Emphasis on short duration modular employable courses and synergizing the school curriculum with vocational training.
5. Making system effective scalable and self healing through continuous revision of curriculum based on demand.
6. Linking Government financing to placement ratios and outcomes and incentivizing both trainers and the trainees.
7. Putting in place labour market reforms for encouraging formal employment and using the apprenticeship as a powerful vehicle for skill development.
